## 16.2 Description

The anchor device, type: Dome light net with fall-through protection is used for the temporary protection of persons against falls from a height. During use a maximum of one person can be secured to the anchor line made of webbing. The system is mounted horizontally.

The system is specially intended to trap a person when falling through a light dome and it consists of a net with the dimensions up to 3.0 m x 3.0 m.

The system is mounted on the curb of the light dome by means of a strapping webbing with tensioning element. The webbing is looped through the net meshes and is attached to the net by additional loops. On the webbing the user can secure himself with the connector of his personal fall protection equipment.

The combination of the fall protection system and the fall-through protection has been taken into account in the EU-type examination.
